**AMENDED<sup>2</sup> FIRST INTERIM QUARTERLY FEE

Pursuant to the *Order Establishing Procedures for Interim Compensation and Reimbursement of Expenses of Professionals Pursuant to Sections 331 and 105(a) of the Bankruptcy Code*, entered on November 12, 2009 [Docket No. 104] (the "Interim Compensation Order"), the professionals retained by the above-captioned debtor and debtor in possession (the "Debtor"), hereby apply for an interim quarterly allowance of compensation and reimbursement of expenses (the "Fee Request") for all interim applications filed during the previous quarterly period covering the period from October 18, 2009 through and including December 31, 2009. Summaries of the fees and expenses that are the subject of this Fee Request are summarized in the attachments hereto.

PLEASE TAKE NOTICE that pursuant to the Interim Compensation Order, the Debtors were authorized to pay on an interim basis 80% of the amount of compensation


requested and 100% of the amount requested for reimbursement of expenses without further order of the Court upon the expiration of a 20-day objection period.
